NEW HORIZONS HAS GROWN TO OFFER SEVEN PROGRAMS, FREE OF CHARGE, TO OVER 600 STUDENTS K-12 AT 10 LOCATIONS IN SW FLORIDA. IN 2021-2022 DESPITE THE PANDEMIC SETBACKS, OVER 70% OF OUR K-5TH GRADE STUDENTS WERE ABLE TO INCREASE THEIR LANGUAGE ARTS GRADES TO A "C" OR BETTER. EIGHTY-EIGHT PERCENT OF THE TEENS GAINED IN THEIR GRADES WITH A 2.0 OR GREATER GPA (OVER 60% WITH A 3.0 OR GREATER GPA). OVER 90% OF THE STUDENTS BELIEVE THAT THEIR FAITH HAS GROWN.
